

## OEA cuts 2014 board by 10 positions

The Ontario Energy Association has pared its board of directors nearly in half as the industry group that represents 150 of the largest corporate players in the province's energy sector refocuses.

In the midst of a strategic rebranding toward advocacy, education and networking, the OEA announced Monday it cut its board to 14 from 24 and reduced membership categories from five to four.

Eight industry leaders, four market retailers and two sector partners will now sit on the board with potential variations in sector representation, the association said.
